ESCAN provides its affiliates with indirect membership to nonprofit organizational resources through ESCAN's direct membership participation. Affiliates receive nonprofit specific materials and periodic notifications of programs and resources to the nonprofit community.

ESCAN maintains a website and provides other support for affiliates which provides materials and resources that promote client development, assist in volunteer recruitment and training, help establish internal operational guidelines and standardization and presents tools for the delivery of consulting services to their nonprofit communities. These local organizations receive access to internal and external resources and publications.

For 2011, ESCAN's affiliates provided 81,000 hours of consulting services by approximately 1,500 volunteer consultants on 1,400 projects serving over 1,000 nonprofit organizations.
